DATA PROTECTION BE IN CONTROL OF YOUR DATA

When you give your personal details to an organisation or individual, they have a duty to keep these details private and safe. This process is known as data protection.

Organisations or individuals who control the contents and use of your personal details are known as 'data controllers'. Under data protection law, you have rights regarding the use of personal details (Data) and data controllers have certain responsibilities in how they handle this information.

Under the Data Protection Acts 1988 and 2003 employers are "Data Controllers" and breaches of Data Protection Legislation may lead to fines of up to €100,000 by the Data Protection Commissioner.

9 RULES OF DATA PROTECTION

- OBTAIN AND PROCESS INFORMATION ETHICALLY
- ✓ DATA MUST BE KEPT SAFE AND SECURE
- IT MUST BE KEPT FOR A SPECIFIED, LAWFUL PURPOSE
- ✓ IT SHOULD BE USED AND DISCLOSED ONLY FOR The specified purpose
- IT MUST BE UP TO DATE, ACCURATE AND COMPLETE.
- ✓ IT MUST BE RELEVANT, ADEQUATE BUT NOT EXCESSIVE
- DATA MUST BE RETAINED FOR NO LONGER THAN IS NECESSARY
- A COPY OF THE DATA MUST BE MADE AVAILABLE TO THE DATA SUBJECT, ON REQUEST.
- ✓ OBSOLETE DATA MUST BE SECURELY DESTRUCTED


- YOUR DETAILS ARE HELD ON A COMPUTER
- HELD ON PAPER OR OTHER MANUAL FORM AS PART OF A FILING SYSTEM
- MADE UP OF PHOTOGRAPHS OR VIDEO RECORDINGS OF YOUR IMAGE OR RECORDINGS OF YOUR VOICE.

THE AIM OF THESE RIGHTS ARE TO ENSURE INFORMATION STORED ABOUT YOU IS:

- FACTUALLY CORRECT
- ONLY AVAILABLE TO THOSE WHO SHOULD HAVE IT
- ONLY UTILISED FOR STATED PURPOSES

The Freedom of Information Acts grant every person a right, subject to certain restrictions, to access information held by Government Departments, agencies and other designated bodies in receipt of State funding. 
